# Senator Evan Bayh: A Proven Democratic Winner Appearing as

Speaker at Tenth Dems Event in Highland Park

Senator Evan Bayh is a Democrat on a winning streak.

He won for Secretary of State in 1986 in his first statewide race. He was elected governor in 1988, and again in 1992 with 62 percent of the vote. He was elected to the U.S. Senate in 1998 with 64 percent of the vote, and re-elected in 2004 with 62 percent.

The numbers make you think that he must come from a very Democratic state. But the fact is, he is from Indiana, a state that has gone for the Democratic candidate only four times in the past 27 Presidential elections. Somehow, Evan Bayh, 50, is a Democrat who consistently wins in very Republican territory.

How does he do it? When Senator Bayh speaks at a Tenth Dems fundraiser on Friday, June 30, maybe he will give us some clues. Maybe he will give us an idea of how a Democrat can win 62percent of a state's vote while

Republican George W. Bush can do no better than 60 percent. Maybe he will tell us how a Democrat can win by such a large margin when the state's voters are choosing a Republican for Governor, picking Republicans to control every state office on the ballot. electing Republicans to seven of nine Congressional seats, and giving control of both houses of the state legislature to Republicans? That's what Evan Bayh did in 2004.

Some might argue that it's all in the name. The Bayh name has been a part of statewide politics in Indiana since 1962 when his father, Birch Bayh, was elected to the first of three terms in the Senate. As some people named Daley, Kennedy, Clinton, Stevenson, Madigan, or Bush can tell you, a familiar name does help the first time you run. But from there, you're on your own.

# What Mark Kirk Doesn't Get with his Suburban Strategy

Mark Kirk has been traipsing around the country with his message that we are supposed to ignore national and international issues and focus on local issues that affect suburbanites (which sort of begs the question of why with a local plan he needs to do all the nationwide traipsing). 401K accounts for babies are in his focus – he doesn't want to talk about the war, NSA spying, failed prescription drug plan and a nonexistent healthcare plan, and tax cuts for the wealthy.

Kirk has said: "Suburban families feel they are under attack and believe they need a voice in Congress," and he is correct in that statement. But what Kirk doesn't get is that all the national and international issues he wants us to ignore are the source of our feeling under attack.

Bush's and Kirk's war in Iraq has placed a financial burden on the country that suburban children will pay for the rest of their lives and has led to a budget that cuts funding of education programs, grants and student loans. Recent grads call themselves "Generation Broke," because they are saddled with about 20 years of debt after graduation.

Kirk thinks education means funding Chinese language courses and checking teacher backgrounds, but subjects like science and math that help us be innovators and job creators are being de-emphasized. Kirk stays silent while his party pushes religion over science in the schools and vouchers public education into oblivion. These issues are important to suburbanites, but cannot be found in the suburban agenda.

Kirk is focusing on baby 401Ks, but he is not interested in a health care system that works for them and their parents. He's content to keep us in costly health care programs which burden both businesses and families. The cost of heath care prevents many from getting any, so those babies that he wants to give 401Ks to might not survive to collect on them. Health care is the major cause of bankruptcies, but Kirk voted for changes that punish people forced into bankruptcy due to catastrophic illness. We are not supposed to pay attention to that according to Kirk as no health care plan is in the suburban agenda.

The NSA spying Kirk wants us to ignore also affects suburbanites. It goes to the notion of government accountability. As the government increases its control over the people and chills free speech, it decreases its accountability to them. That is what happened in the Soviet Union. There was no accountability to the millions

injured by the nuclear accident at Chernobyl because over years of oppression, the people knew they had no voice, and no recourse against the government.

In the U.S., we also have connected corporations to think about and we are seeing decreased regulation and caps on injury awards in court cases. Speech is chilled, recourse is eliminated — and we are seeing the effects of these accountability reverses in the deteriorating safety of our food, drugs and water; in the eroding quality of our health care; and in the alarming state of our environment. If we don't stop this trend, we will have damages, but no say in policy or recourse for bad policy.

Here in the Illinois 10th Congressional District, we may not be on the cutting edge of world affairs. Most of us are just trying to make a living and a life for our families, so national issues can seem far away and life can be mundane. Our real issues are as they have always been, preventing the kids from killing themselves on their bikes and helping them make it through college, paying the mortgage, putting food on the table and gassing up the car. Thing is, the national issues that Kirk wants us to ignore are exactly the issues that are making suburbanites feel under attack.

Kirk does not understand that it is the totality of the downturns and backward thinking of his party's agenda that has been the disaster for the entire country, including the suburbs. The national issues that are missing from Kirk's suburban strategy — the budget deficit; trade imbalance; unemployment and outsourcing; unscientific thinking causing us to give up our role as the world's innovation leader; lack of affordable education; loss of opportunity; lack of healthcare and secure, well-paying and safe jobs; oil prices increasing the cost of everything; and the deflation of our national spirit caused by all of the above — are the issues that matter to suburbanites.

Under Kirk's suburban agenda, we will lose our voice, our recourse, our education, our money, our health, our opportunity, and our hope.

To protect our families and our suburban communities we need to go back to sensible American freedom with power in its citizens and an accountable government and tell Kirk that he has the wrong agenda for the suburbs.


some of those committeemen, just to run for township offices in 2005, and to run for Congress in 2006.

# Wrap Yourself in a Flag, and Give Yourself a Raise Seals questions Kirk's pay increase, cuts in veterans' benefits

It's time for the 4th of July. Out come the flags as we celebrate our nation. It's a fun and colorful American tradition.

It's also the time for another tradition: The Republican Party's attempt to amend the U.S. Constitution to make flag burning illegal. As the Chicago Sun-Times pointed out in a recent editorial, "this is a classic example of a solution in search of a problem." As the Sun-Times points out, not one protest of the war in Iraq has featured a flag burning. In fact, there have been almost no flag burnings at all in recent years. If the Republicans succeed (and Mark Kirk is on record as a solid supporter of this amendment) it would be the first time in American history that our Constitution has been used to restrict any form of free speech.

So why this attempt to change the Constitution? It's the same reason Republicans are suddenly interested in banning gay marriage after two years of ignoring the issue, why they are trying to stir up emotions on immigration, and why they are trying to scare us again into thinking that only Republicans can keep us safe. It's an election year. It's time for Republicans to act angry and scream, "We are patriotic, God-fearing Americans, while liberal Democrats hate our country and our values."

If you're a Republican, it's time to take the flag out of your closet and wrap it around yourself, and to declare that those who oppose the war in Iraq do not support our troops. To his credit, Mark Kirk has never been quoted as saying that. But he does claim that he supports the troops. Really?

Dan Seals, the Democratic nominee for Congress, is just one of many who look at Kirk's rhetoric and compare it to his votes and notice that something doesn't add up. "Just last year," Seals noted, "Kirk voted to cut veterans' benefits by \$13.5 billion over five years. Two years before that he voted to cut the same benefits by \$30 billion over ten years." A Kirk news release from May 2005 said that Kirk promised to work towards providing "our nation's veterans with state-of-the art health care here at home." Great! But why did he then, Seals asks, "repeatedly cut the programs which provide that care?"

Perhaps the answer that Mark Kirk would give to that question is that as a Congressman who has supported every tax cut that has come before Congress, he has the difficult job of controlling our spending and choosing our priorities. OK. Let's put aside for the moment the counter-argument that giving tax cuts to the wealthiest Americans should not be a higher priority than caring for the soldiers we send to war. What spending programs win support from

Mark Kirk? What is more important to him than helping veterans of a war he has consistently supported from the start?

Well, in June, Mark Kirk voted to give himself a pay raise.

Mark Kirk votes to cut funds for veterans, votes to cut back on student loans, says we can't afford Medicaid, Medicare and Social Security, but votes himself a pay raise. He has supported cuts in money to go after child-support slackers, for enforcement of environmental laws, for spending on education, child care, job-retraining and for our national parks. For this, Mark Kirk deserves a pay raise?

Dan Seals says if he's elected, he will have different priorities than Kirk, priorities which better reflect the feelings of the thousands of people in the 10th District who will hang their flags on their homes and who will cheer as the veterans march by during the 4th of July parades. "It is our duty to provide our nation's retired serviceman with the very best care - this means well-funded programs, job training and assistance, and, yes, state-of-the-art health care. In the greatest nation in the world, we cannot allow any veteran to be without the care they have valiantly earned. I believe true leaders would not put their own bottom lines over that of our armed forces in a time of war."

Hey, Can This Yacht Run on E85?

While scientists used to believe these sorts of things happened cyclically, Gore's graphs show that in recent years, the figures have grown so much that they are literally off the charts.

The facts are real. There is 100 percent agreement among scientists. For that reason, Gore argues, the issue is not political. It's moral. And it's up to each individual to help stop it, because, as Gore states in the movie, "You can't make somebody understand

something if their salary depends upon them not understanding it."

During the post-movie discussion, Learner informed the group that the Midwest is actually responsible for five percent of the carbon dioxide pollution in the world and 20 percent in the United States. Because the Midwest has the largest concentration of coal plants as well as plenty of truck drivers, we omit more pollution than most countries in the world. "We are the center of the problem," said Learner. "We must be the center of the solution."

Learner listed several ways to combat global warming, including solar power and getting more gas miles per gallon. He explained that ten years ago, cars got 40-50 miles per gallon, while today they get 20-30. Getting 40-50 miles per gallon would essentially cut global warming in half. He urged people to buy compact fluorescent lamps (CFLs), which use one-fourth as much electricity as normal light bulbs and are ultimately cheaper because of the money saved in energy costs.

"We know the problems. Scientist agree on the impacts," said Learner. "We need to find a way to transform frustration into action."

Along with individual efforts, it's crucial to have a government that understands and places priority on environmental issues. Mark Kirk has an inconsistent record on oil drilling in the Arctic National Wildlife Reserve, voting in favor of drilling on close votes in the House, but against it when the outcome is one-sided. He has also supported a mass sell-off of public lands, a weakening of clean air laws, against environmental justice, in favor of cuts in funding for environmental protections, and against scientific integrity in public policy making. Kirk's voting record is why the League of Conservation Voters gives him a pathetic 39 percent approval rating on environmental issues.

Global warming is what Learner calls "the challenge of our time." The inconvenient truth is that if we fail to act, temperatures will keep rising, hurricanes will keep coming, glaciers will keep melting, and the world as we know it might not exist for much longer.

But with the right government officials, individual efforts, and the decision to act, we can combat global warming. That is the hopeful truth.
